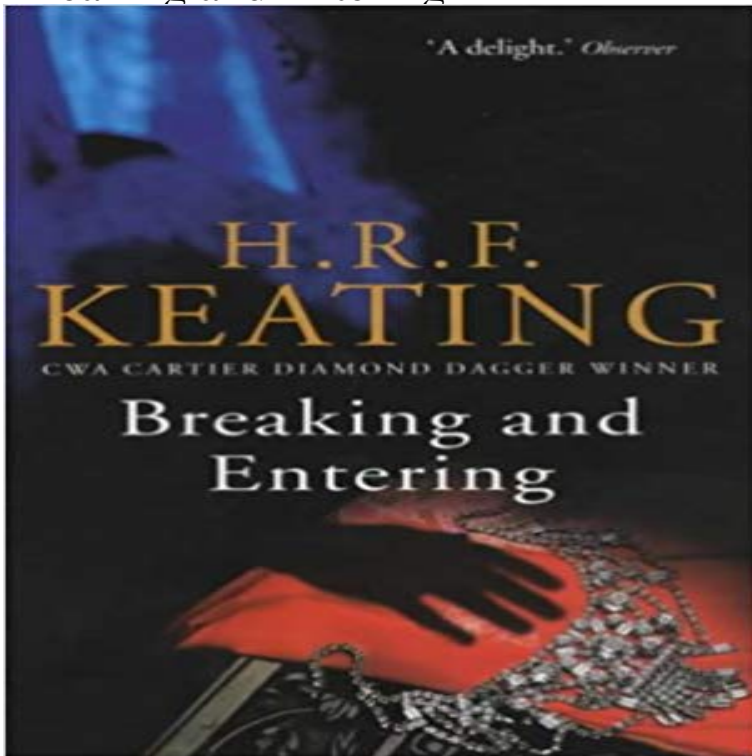


Breaking and Entering
