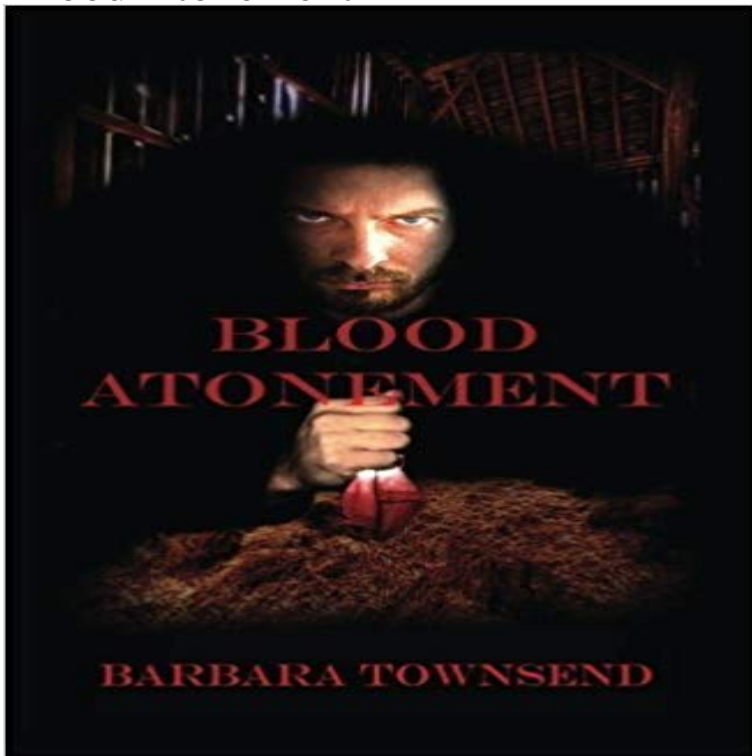


## Blood Atonement
